An Announcement of Khon Kaen University 230/2012

On the Rules, Regulations and Application for the KKU Scholarship for ASEAN and GMS Countries' Personnel of Academic Year 2012

Khon Kaen University, as one of the nine national research universities, has always taken an important role to participate in developing personnel and resources of the countries in the Mekong Sub-region, especially the neighboring countries: Laos, Kampuchea, and Vietnam. Presently, Khon Kaen University is extending its role in human resource development of the regional Asian countries to respond to the coming ASEAN Community in 2015. Human resource development is the heart of all aspects of national development. Collaboration among academic institutions of the countries in ASEAN Community is vital and a necessity in response to the role of ASEAN Community in the world society and augmentation of the potentiality of our regional human resources. This is especially true in academic and research work, which Khon Kaen University has continuously encompassed, in its major mission towards the Me Kong Sub-regional human resource development.

Therefore, by virtue of Article 20 and 23(1) of The Khon Kaen University's Act of 1998 and Article 6 of Khon Kaen University's Rules and Regulations pertaining to the University's proceedings, the University has proclaimed the following announcement.

Article 1 This announcement is referred to as "An Announcement of Khon Kaen University number 230/2012 on the Rules, Regulations and Application for the KKU Scholarship for ASEAN and GMS Countries' Personal of Academic Year 2012".

Article 2 This announcement is to come into effect the day following the official announcement.

Article 3 In this announcement:

University refers to Khon Kaen University.

Faculty refers to the Faculty or the Institute equivalent to the Faculty of Khon

Kaen University which offers the program for a student who

wishes to enroll.

Committee refers to the Committee responsible for carrying on the scholarship

program for our Neighboring Countries' Personnel.

ASEAN Community refers to the nine countries in ASEAN Community including Laos,

Cambodia, Vietnam, Myanmar, Indonesia, the Philippines,

Brunei, Malaysia, and Singapore.

Article 4 Eligibility

- 4.1 The applicant must hold one of the nationalities of these mentioned ASEAN or GMS countries. In the case where the applicant is from a different country or is of another nationality, the applicant must be personnel of a university that has signed a Memorandum of Understanding (MOU) with Khon Kaen University that clearly states the reciprocal basis scholarship.
- 4.2 The applicant must have the official permission to study at Khon Kaen University from the institute/organization for which the applicant is affiliated to in the homeland country, and must be able to show the authorized signature of the highest rank officer in charge or by a person with the equivalent authority.
- 4.3 The applicant must fulfill all the requirements as per those who are eligible to study in that particular curriculum at Khon Kaen University.

Article 5 Scholarship Categories

This scholarship is offered for regular programs, international programs or English programs at a graduate level at KKU. This scholarship <u>does not include the special projects or special programs</u>. There are three types of scholarships which are as follows:

- Full Scholarship that covers the tuition fees, which is not to exceed 150,000 baht per year and other living expenses and miscellaneous costs not exceeding 96,000 baht per year and research/thesis costs not exceeding 18,000 baht per year. The scholarship will provide support for the stated duration of the program only, and if the recipient is unable to graduate within this period, he/she will be responsible for any additional expenses to complete the study.
- Partial Scholarship for the applicant who has already received some support from an external organization. The Partial Scholarship will cover tuition fees not exceeding 150,000 baht per year or covers the living expenses not exceeding 96,000 baht per year and research/thesis costs not exceeding 18,000 baht per year depending on each case. The scholarship will provide support for the stated duration of the program only, and if the recipient is unable to graduate within this period, he/she will be responsible for any additional expenses to complete the study.
- Partial Scholarship for the applicant who has already received some support from the KKU Faculty. This scholarship will cover tuition fees not exceeding 150,000 baht per year or covers living expenses not exceeding 96,000 baht per year and research/thesis costs not exceeding 18,000 baht per year depending on each case. The scholarship will provide support for the stated duration of the program only, and if the recipient is unable to graduate within this period, he/she will be responsible for any additional expenses to complete the study.

Khon Kaen University will support the travel expenses for <u>Scholarship Type 1 only</u> at first arrival and when the graduate departs following completion of their studies as follows:

- A round-trip air ticket (economy class) issued by Thai Airways International Co. Ltd. to and from the designated capital city or principle city (<u>Excluding</u> domestic airfare in both Thailand and ASEAN or GMS countries), <u>or</u>
 Transportation for recipient from Lao PDR, Cambodia and Vietnam will be covered for a bus or
- 2. VISA extension <u>first time within Thailand only</u> (VISA validation 3 months from Royal Thai Embassy from the designated capital city)

- Article 7 Budget

- Article 8 Application Process

Those who are eligible for the scholarship must submit an application form to study at Khon Kaen University along with the following documents:

8.1 <u>Two original copies</u> of the application package would be required.

- 8.2 Official academic transcripts of school study, undergraduate study, graduate study (only for those who have completed their graduate study). If the documents are not the original, the copied form must be officially certified by the original institution.
- 8.3 An authorization letter of permission the applicant to study from the institute/organization for which the applicant is affiliated to from the homeland country, provided with the authorized signature of the highest rank officer in charge or by a person with the equivalent authority.
- 8.4 Copies of TOEFL or IELTS scores (if applicable).
- 8.5 If the applicant is receiving any other financial support by another organization, either international or domestic, the applicant must provide copies of the grant/scholarship where the amount and type of financial support received is clearly stated.
- 8.6 A copy of the MOU between the applicant's home Institute/University and Khon Kaen University (only for those applicants who come from a University that has an MOU with KKU).
- 8.7 In the case where the applicant fails to complete any part of the application, especially Article 8.5 (other sources of scholarship), the scholarship committee will cancel the application immediately.

Article 9 The Rules and consideration for the selection process

- 9.1 KKU will <u>consider the original copies of application only</u>. We do not accept the application via e-mail or fax.
- 9.2 The applicant must be nominated by the university or institution (Faculty or the Institute equivalent to the Faculty which offers the program that he/she is applying for the scholarship).
- 9.3 The applicant must have the official permission to study at Khon Kaen University from the institute/organization for which the applicant is affiliated to in the homeland country, provided with the authorized signature of the highest-ranking officer in charge, or by another who has the equivalent authority.
- 9.4 The applicant who comes from the university/institute/organization that has a Memorandum of Understanding with Khon Kaen University (at the Ministry of University Affairs level, University level or at the Khon Kaen University's Faculty level) or those who will be return to workplace for develop their institution/university will have first priority. Those who come from institutions that do not have a Memorandum of Understanding with Khon Kaen University will receive secondary priority.
- 9.5 The applicant who is applying for the Scholarship Type 2 or Type 3 will receive first priority over those who are applying for Type 1 scholarships, respectively.
- 9.6 The scholarships for ASEAN and GMS Countries' Personnel will be evenly distributed among the Faculties and departments, and the scholarship recipients should come from various faculties and departments, except in the cases that contradict other conditions announced.

Article 10 Conditions in accepting the scholarship

10.1 The time frame for the scholarship should correspond to that set by each curriculum. If the applicant fails to complete his or her studies within the set period of the curriculum, he/she must cover any additional costs for the extended study period by himself.

- 10.2 The scholarship recipient and the Faculty of the scholarship recipient must submit his/her study report every semester, which will then be used in the consideration for the scholarship renewal for the coming academic year.
- 10.3 The decision to continue awarding the scholarship to the recipient in each coming academic year is up to the judgment and performance assessment by the scholarship committee.
